## How to Request an IRS Verification of Non-Filing Letter

For individuals who did not file a 2020 federal tax return, we are required to collect IRS documentation to confirm that no tax return was filed. Dependent students are exempt from this requirement. A Verification of Non-Filing Letter can be requested from the IRS at **IRS.gov.** 

- Navigate to: www.irs.gov/individuals/get-transcript
- Under "Request Online" click the link labeled "Get Transcript Online" You may need to register an account to use this service, if you do not already have one. Secure personal information will be required to register.
- When asked for the Type of Transcript, select "Verification of Non-filing" for tax year 2020.
