## **Important Facts to Understanding Certification**

- Audited, non-credit and online remedial cases cannot be certified to the Veterans Administration.
- All failed cases are reported to the VA and could result in overpayments.
- "Blended" or "hybrid" courses will be certified as online classes.
- If you are taking online classes only, you are not eligible for full BAH payments.
- You will be certified only for classes required in your degree/certificate program. Any classes not on your attached degree plan cannot be certified to the VA. Changes to your schedule after this form is submitted will cause considerable delays in receiving your payments. (Confirm your schedule with your academic advisor before registering to prevent adding and dropping of classes.)
- You can only be certified for time spent in class. All classes are reported to the VA on a start and end basis, which is how your entitlement money is based.
- The position of Veterans Affairs Student Counselor at Regis University is to certify and advise veteran students. We do not work for the Veterans Administration nor have access to any VA files. We cannot guarantee you will receive benefits or when those benefits will arrive.
