#### **APPLICATION REQUIREMENTS**

To apply to the Neonatal Nurse Practitioner (NNP) post-graduate certificate program, you will need:

- I Minimum two years nursing work experience in a Level III or IV high-risk neonatal intensive care unit
- I Complete online application through NursingCAS
- I Nursing Master's degree from an NLN or AACN-CCNE accredited program
- I All transcripts from all institutions attended sent directly to NursingCAS
- Current resume
- I One-page personal statement
- I Three recommendation forms from a NNP/Neonatologist and a colleague

The first step in the application process is to contact an admissions counselor, who can evaluate your prior learning credit, provide information regarding financial aid and tuition assistance and help you through the entire application process.
