**Merit scholarships awarded to you through the Office of Admissions are for the Fall and Spring semesters only.** Dependent on your eligibility, you may be able to receive Colorado Graduate Grant and Graduate Student Loans for the summer semester. Grant aid is dependent on funding availability and enrollment.

- **Colorado Graduate Grant:** Regis University limits Colorado Graduate Grant to **\$2,500/semester**. This amount is based on full-time enrollment. If you are attending less than full-time, your grant may be prorated.

- **Federal Direct Unsubsidized Loan:** The U.S. Department of Education regulates the annual total amount of Federal Direct unsubsidized student loan you may borrow to **\$33,000/year**. If you are in your final year of your program, you may qualify for up to \$37,167.
  - Any Federal Direct unsubsidized loan you wish to borrow for the Summer semester **will reduce** the amount of loan available to you to use during the Fall and Spring semesters.
