APPENDIX

RELEASE FROM RESPONSIBILITY, ASSUMPTION OF RISK, AND WAIVER

In consideration of my being permitted by Regis University to participate in Club Sports during the 2016-2017 academic year I am exercising my own free choice to participate voluntarily in club sport activities, and promising to take due care during such participation, hereby release and discharge, indemnify and hold harmless the State of Colorado acting through the Board of Trustees of the Regis University, and their officers, agents, employees, and any other persons or entities acting on their behalf, and the successors and assigns for any and all of the aforementioned persons and entities, against all claims, demands, and causes of action whatsoever, either in law or in equity, relating to injury, disability, death or other harm, to person or property or both, arising from my participation in and/or presence at the above-listed activities.

I acknowledge that I am aware of any hazards and risks which may be associated with my participation in the above-named activities. I understand, accept, and assume those hazards and risks, and waive all claims against the State of Colorado acting through the Board of Trustees of Regis University, and other persons as set forth above. I understand that I am solely responsible for any costs arising out of any bodily injury or property damage sustained through my participation in normal or unusual acts or conduct associated with the above-named activities.

I have had sufficient time to review and seek explanation of the provisions contained above, have carefully read them, understand them fully, and agree to be bound by them. After careful deliberation, I voluntarily give my consent and agree to this Release, Assumption of Risk, and Waiver. I certify that I am over the age of eighteen years, and have read and executed this document.

CLUB SPORTS GRADE POINT AVERAGE RELEASE

I agree to release my individual grade point average to the Coordinator of Intramurals and Club Sports and my team coach. I understand that my grade point average may be used for recognition of academic success, and may impact my eligibility depending on my teams' league/association requirements and the Club Sports program requirements.

CLUB SPORTS PHOTO RELEASE AND WAIVER

I do hereby give Regis University, its assigns, licensees, and legal representatives the irrevocable right to use my name (or any fictional name), picture, portrait, or photograph in all forms and media and in all manners, including composite or distorted representations for advertising, trade or in any other lawful purposes, and I hereby forever waive any right to inspect or approve the finished product, including but not limited to, written copy and/or posting image on website, that may be created in connection therewith. I am of full age (18). I have read this Release and Waiver and am fully familiar with its contents. I understand that Regis University cannot control the use of my name or image once such name or image is published.

PERSONAL VEHICLE USE WAIVER

Wellness and Recreation strongly recommends the use of a Regis University vehicle, or rental vehicle, to transport Club Sport members from campus to off-campus games, performances, and activities whenever possible. Regis University and Wellness and Recreation do not provide insurance for the vehicle or its driver or occupants and are not liable for personal injury or property damage, including damage to the vehicle incurred during Club Sport travel. As owner of the vehicle, I understand that I may be exposing myself to personal liability in the event of an accident. With the foregoing understandings, I voluntarily undertake of personal vehicles for travel of my club sport for this year. I have read and understand the Wellness and Recreation policies and recommendations regarding travel associated with Club Sport activities. I release and fully discharge Regis University from all liability in connection with the use of my or a teammate's vehicle for Club Sport travel for or on account of any injury or illness of myself or death, or that of any passenger in my vehicle, or for or on account of any loss or damage to any personal property or personal effects owned by me or any passenger.

CLUB SPORTS ALCOHOL AND DRUG POLICY

Consumption of alcohol is prohibited during all Club Sport activities, regardless of the age of the participants. Non-prescribed drugs, performance enhancing drugs, or any other substances that might be dangerous or detrimental to the participant's health, or performance as a member of this club are also prohibited. Club activities are defined as any social, practice, competition, demonstration, clinic, or community service event sponsored, hosted, or arranged by or for club members.

Travel is considered a club activity from the time of departure to return.

CLUB SPORTS PARTICIPATION AGREEMENT

All Club Sport program participants have an obligation to refrain from actions and behavior that may jeopardize themselves or other Club Sport participants. The Club Sports program at Regis University reserves the right to remove participants from the program for actions/behavior that are deemed dangerous or detrimental to themselves and/or other Club Sports program participants.

Participants are required to observe all applicable laws and ordinances of applicable governmental authorities as well as the rules and regulations of service providers, including hotels, hostels and airlines.

Violations of conduct codes, laws, or provisions may result in penalties including, but not limited to, termination of your participation in the season or competition. Any participant who violates these standards will remain liable for any and all expenses related to the event and related travel, as well as the amount of costs incurred by Regis resulting from, in any way, the misconduct of the participant.

Participants on a trip agree not to leave activities or accommodations independently of the group and to keep the coach informed of their whereabouts at all times. Participants further agree to set, in consultation with the Coach and/or Coaches, reasonable times for their return to hotel accommodations each night and to abide by those time limitations.

Participants must abide by decisions of the coaches in the event of emergency situations. Participants will provide the University with emergency contacts prior to participation.

CLUB SPORTS NON-HAZING COMPLIANCE POLICY

Regis University interprets hazing as any act, whether accomplished through physical, mental, emotional or psychological means, which subjects another person, voluntarily through coercion or intimidation or as a condition of participating in a student activity or partaking of a student benefit, or involuntarily, to anything that may abuse, mistreat, degrade, humiliate, harass, or intimidate an individual, or which may, in any fashion compromise an individual's inherent dignity or physical safety. In addition, any requirements by a student that compel another student to participate in any activity that is against University policy or federal, state, or local law will be defined as hazing.

Violation of the hazing policy shall subject an individual or group to the full range of disciplinary sanctions pursuant to the Regis University disciplinary process up to and including termination of membership in the Club Sport.

NONDISCRIMINATION AND SEXUAL MISCONDUCT POLICY

Regis University does not discriminate on the basis of race, color, national origin, sex, disability, age, religion, veteran status, marital status, pregnancy, parental status, gender identity, sexual orientation, genetic information or any other legally protected status in any of its policies, programs or activities and provides equal access to education.

All Regis University community members (faculty, students, staff, administrators, trustees, contract personnel, agents, visitors, invitees, and volunteers) are prohibited by law from engaging in acts of discrimination, including sexual harassment or sexual violence. Regis University's non-discrimination policy extends to employment, education and admission. Regis will take immediate and appropriate corrective action up to and including expulsion or dismissal, in cases where it has been determined that discrimination or sexual misconduct has occurred.
