August 2011 – April 2012 FAA Director, Information Security, Chief Information Security Officer

As the CISO, Christopher led the FAA's enterprise information security program as the sole senior executive that manages an annual budget of \$50M, 13 offices and facilities nationwide, and 1152 employees. With a diverse program of eight major projects, and a responsibility to ensure the safety of the National Airspace System, the program responsibilities were worldwide in their reach and global impact.

March 2001 – September 2007 Program Director, FAA Cyber Security Incident Response Center

As the founding Director, Christopher planned, developed, constructed, and implemented to full operating capability the agency's security operations center. A 24x7 facility offering the detection and response to cyber incidents and terrorism, he managed all aspects such as operations, budgeting, hiring and procurement for five locations nationwide and operational locations located throughout the world. The center was modeled on Christopher's authored federal approach of a process to incorporate disparate security operations centers titled the *Centers of Excellence, Situational Awareness and Incident Response (COESAIR)*.

February 2000 – February 2001 Program Manager Outreach, Office of Information Systems Security

Christopher established a team of U.S. delegates to support the creation of an annex to the International Civil Aviation Organization (ICAO) tri-yearly proceedings. The annex began the process to establish international standards for cyber security responsiveness to threats to international aviation on a global scale.

Christopher managed the technical operations and field support units providing second-level support of the systems of the National Airspace System ensuring the safety and security of the nation's highways in the skies.
